

- 2) Product and service life-cycles are often much longer than Eclipse community based maintenance as it stands today. What do you do after SR2?




What if you need a company specific fix after release?







- 1) git clone
- 2) maven clean install
- 3) Done Packaged SDK zip files ready

Premium Services



Annual membership dues provide 1 year of the following:

Service	Description
Bug Privacy	Can keep bugs "private" using company-only bug tracking groups prior to commit.
Maintenance Committers	Appoint maintenance committers that can develop and build in the LTS forge.
Build Infrastructure	Can build and sign software (as the Eclipse Foundation) from the LTS forge.
Advanced tools	Use of tools available to LTS Premium members only.
Directory Service	Access the LTS directory of providers and consumers.

LTS IWG Steering Committee and Premium Members receive LTS Premium Services at no added cost.

LTS Readiness



To be considered LTS-Ready, a project must:

- Store code in a distributed code repository supported at Eclipse (e.g. Git)
- Build with CBI
- Adheres to Eclipse IP policies and especially: only pulls dependencies from Foundation controlled sources such as Orbit, Maven.eclipse.org, downloads.eclipse.org, etc
- Manage bugs in Bugzilla and have meta data capable of routing bugs to each LTS release
- Release software as part of the annual simultaneous release
- Provide an automated testing suite
 Or
- Be approved as a LTS project by the LTS Steering Committee

LTS Participant Member Dues



Dues are assessed using sliding scale based on revenue as follows:

Annual Turnover	Annual Dues
> \$250M	\$10,000
> \$100M <= \$250M	\$10,000
> \$50M <= \$100M	\$7,500
< \$10M <= \$50M	\$7,500
< \$10M	\$5,000
< \$1M & < 10 employees	\$1,500

[•] LTS **Participant** dues are incremental to Eclipse Foundation membership dues. Must be Solutions member or higher.

LTS **Premium** Member Dues



Dues are assessed using sliding scale based on revenue as follows:

Annual Turnover	Annual Dues
> \$250M	\$20,000
> \$100M <= \$250M	\$20,000
> \$50M <= \$100M	\$15,000
< \$10M <= \$50M	\$15,000
< \$10M	\$10,000

- •LTS Premium membership includes all rights and privileges of LTS Participant membership.
- •LTS Premium dues are incremental to Eclipse Foundation membership dues. Must be Solutions member or higher.
- LTS Premium membership is provided at no additional charge to Eclipse Foundation Strategic Members paying dues in excess of (\$100K)

LTS Steering Committee Member Dues



Dues are assessed using sliding scale based on revenue as follows:

Annual Turnover	Annual Dues
> \$250M	\$30,000
> \$100M <= \$250M	\$30,000
> \$50M <= \$100M	\$20,000
< \$10M <= \$50M	\$20,000
< \$10M	\$15,000

- •LTS Steering Committee membership includes all rights and privileges of LTS Premium membership.
- •LTS Steering Committee dues are incremental to Eclipse Foundation membership dues. Must be Solutions member or higher.
- LTS Steering Committee membership is provided at no additional charge to Strategic Members paying the maximum level of dues (\$250K)
